



The Pool – Customer Ticket Competition 2024

1. This competition is being run by the Water Corporation of Western Australia (ABN 28 003 434 917) (**Water Corporation**).
2. This competition is not sponsored, endorsed, administered or associated with Facebook, Instagram, X or any other social media platform on which it is advertised.
3. Instructions on how to enter and other details contained within the Water Corporation promotional advertisements for this competition form part of these Terms and Conditions.
4. Entry into this competition is free.
5. By entering this competition, entrants agree to abide by these Terms and Conditions.
6. This competition commences at 12.01am on 30/01/2024 and closes at 11.59pm 07/02/2024.
7. To be eligible, entrants must:
 - (a) at the time of entry, be 18 years of age or over;
 - (b) submit an answer to the question: *What's your favourite water memory - Share a photo or video of your favourite water memory and tell us about it in 100 words or less* via Facebook, Instagram or email to partnerships@watercorporation.com.au in accordance with the instructional material related to this competition; and
 - (c) be able to attend 'The Pool' performance in Perth at Bold Park Aquatic Centre at 8pm on Saturday 17 February 2024.
8. The prize winners:
 - (a) will be selected based on the quality and impact of their water memory, as decided by Brand & Customer Strategy Business Unit within Water Corporation at their discretion;
 - (b) will be notified by their preferred method of entry (either social media or email). No proxies will be accepted and proof of identity, to the satisfaction of Water Corporation, may be required;
