## Meter boxes

All meter boxes are to be installed by Water Corporation or our approved installer, providing all our safety requirements are met.

Subject to your agreement of our [Standard terms and conditions](#), Water Corporation or our approved installer will install the meter box.

Meter boxes can only accommodate services up to 50mm, provided we have not classified the backflow risk as 'high'. Services with a high backflow risk will require a back flow prevention device that will not fit in a box.

# Application for a non-standard water service



## Additional / Reticulation Service (not for building purposes)

- Payment of any Standard Infrastructure Contributions that may apply are the responsibility of the owner.
- The minimum water service charge and any water consumption charges as prescribed in Water Corporation Regulations will be applicable and the responsibility of the owner.
- The internal installation must be arranged through a licensed plumber by the owner.
- Water Corporation will control the boundary service but the cost of maintenance, renewal and disconnection whenever required shall be the responsibility of the owner.
- If required by Water Corporation the owner will have a containment backflow prevention device installed as part of the plumbing system. This will require annual testing and certification by an approved contractor to ensure ongoing function.

## Shire Permanent Exempt Service (not for building purposes)

- The cost of the water service plus hinge box and cover (if applicable) must be paid by the owner/ developer
- The boundary service shall be controlled by Water Corporation but the cost of maintenance, renewal and disconnection whenever required shall be borne by the owner/developer.
- The internal plumbing must be arranged through a licensed plumber by the owner/developer.
- Annual fees and charges for water consumed will be applicable as prescribed in Water Corporation By-Laws and are the responsibility of the owner/developer.
- The annual charge as prescribed by Water Corporation by-laws will be applicable for each sewerage major fixture connected to the sewer main and is the responsibility of the owner/developer.
- The cost of sealing sewer connections whenever required will be the responsibility of the owner/developer.
- The Corporation will be advised of any change in the use of the land or any change of tenancy of the land to which Exempt Land Conditions apply.
- Payment of any Standard Infrastructure Contributions that may apply, are the responsibility of the owner.
- If required by Water Corporation, the owner/developer will have a containment backflow prevention device installed as part of the plumbing system. This will require annual testing and certification by an approved contractor to ensure ongoing function.
